EUROPEAN UNION'S REACH REGULATION DECLARATION CERTIFICATE

The European REACH Regulation 1907/2006 on Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH), entered into force in June 2007, and affects all companies producing, importing, using, or placing products on the European market. The aim of the REACH regulation is to ensure a high level of protection of human health and the environment from chemical substances.

Linear Technology Corporation's substances management system follows and complies with the current revision of the REACH Regulation on the substances as identified by ECHA (European Chemical Agency).

Linear Technology Corporation's products are considered articles as defined in REACH. These products/articles under normal and reasonable conditions of use do not have intended release of substances. Therefore the requirement in REACH for registration of substances contained in these products/articles does not apply.

Linear Technology Corporation's products/article do not contain any of the **Substances of Very High Concern** (SVHC) candidates listed above the regulatory threshold of 0.1% in our products/article nor does LTC's tonnage exceed 1 tonne per importer per year. Therefore the requirement in REACH to notify ECHA of products/articles exceeding these limits is not applicable.

Linear Technology Corporation's European operations do not manufacture or import chemicals; therefore LINEAR TECHNOLOGY CORPORATION is not required to register substances.
